Birangana Sati Sadhani Rajyik Vishwavidyalaya which is situated at Golaghat, P.O. & P.S.- Golaghat within the district Golaghat, Assam, and represented by its Registrar Dr. Uday Kumar Khanikar - hereinafter called the 1st Party, in the One Part.

AND

Purvottar Pradeshiya Marwari Sammelan (PPM) which is situated at 39, Vrindavan Market, Sati Joymati Road, Athgaon, Guwahati-781001, and represented by its President Mr. Kailash Kabra, hereinafter called the 2nd Party, in the Other Part.

WHEREAS the 1st Party is a State University recognised by UGC under section 2(f) of the UGC Act 1956 and the 2nd Party is a social Organization engaged in various types of social works AND WHEREAS the 2nd Party offered the 1st Party to provide 3 (Three) scholarships to students pursuing PhD under the 1st Party to which the 1st Party agreed under the following terms and conditions:

NOW THIS MEMORANDUM WITNESSETH AND IT IS MUTUALLY AGREED AS FOLLOWS:

- That, it is mutually agreed between the parties that the 2nd Party shall provide 3 (Three) Scholarships initially for a span of 2 (Two) years to students pursuing PhD under the 1st Party.
- That, it is further agreed that the scholarships shall be awarded under the banner of the 2nd Party. The 2nd Party shall be the sole sponsor for the initial 3 (Three) scholarships to be awarded to the PhD students. However, individual name or family name of the sponsor may be placed under the acknowledgment.
- 3) That, it is mutually agreed between the parties that the amount of each scholarship shall be Rs. 5,000/- (Rupees Five Thousand) only per month.

- 4) That, it is further agreed between the parties that the scholarships shall be awarded by the 2nd Party only after completion of PhD coursework by the concerned students and shall be awarded only to regular students enrolled in the PhD Programme.
- That, the 1st Party in consultation with the 2nd Party shall initially offer 2 (Two) scholarships for topics relating to Marwari Culture and Tradition and 1 (One) Open scholarship for PhD. However, wide areas of research shall be provided.
- 6) That, the scholarships shall be open for students belonging to all categories and there will not be any sort of reservation.
- 7) It is agreed by and between the parties that scholarships shall be awarded strictly on merit basis and shall be in accordance with Ordinance of the 1st Party and UGC rules.
- 8) It is to be mentioned here that in any case of non-completion of PhD programme, the scholarships shall be withdrawn and remitted and the scholarships may be terminated if the recipient is found to have violated the code of conduct laid down by the 1st Party or if charged by any criminal offence.
