Note: In view of the present flood situation in Assam, it is hereby notified that the 1st Round of Admission to the Bachelor of Medical Laboratory Science (BMLS) will be conducted through online mode on **11-08-2026 (10am onwards)** for the convenience of the candidates.

However, it is mandatory for all provisionally admitted candidates to report physically at the University campus for original document verification within 20 (Twenty) days from the date of admission. If, at any stage, it is found that the information/documents submitted by the candidate are false, incorrect, forged, fabricated or not eligible as per eligibility criteria, the admission shall stand cancelled forthwith, and candidate shall be liable for such disciplinary/legal action as the Institution/University may deem fit, without any claim for refund of fees paid.

2. Admission is subjected to satisfying the eligibility criteria for BPT programmes as prescribed by Srimanta Sankardeva University of Health Sciences, Guwahati.
3. Candidates must produce the following original documents along with a set of self-attested photocopies:
 - a. Printed copy of the Application Form
 - b. Birth Certificate/Certificate of HSLC or equivalent examination showing the date of Birth.
 - c. Mark sheet of 10+2 examinations conducted by authorised Board/ Council.
 - d. If applicable, Passing Certificate of 10+2 examinations conducted by authorised Board/ Council.
 - e. CEE Score Card conducted by **Srimanta Sankardeva University of Health Sciences, Guwahati**.
 - f. If applicable, valid SC/ ST/ EWS/latest OBC-Non-Creamy Layer (NCL)/ PWD certificate issued by the competent authority for claiming admission under reserved category (candidate failing to produce the certificate will be treated as Unreserved category candidate).
 - g. If applicable, Latest EWS certificate issued by the competent authority for the candidates claiming admission against EWS seats should be valid on the date of admission, otherwise the candidates will be considered in General category.
 - h. If applicable, Gap certificate issued by the District Police Authority/ Court affidavit, in case of a break in study after the qualifying examination for more than one year after passing 10+2 examination.
 - i. Two copies of passport size photographs.
 - j. PRC issued by the competent authority/AADHAR card.
1. **Fee payable (Online)** at the time of counselling/admission: **Rs 22,800.**
2. Candidate reporting late (i.e., after announcement of her/his name) during the counselling/ Admission, he/she may only be considered at the end of the counselling session.
3. Seats under reserved categories that remain unfilled will be converted into Open Category in the due course of time.
4. EWS Reservation will be provided in accordance with Government norms.
