Important Instructions/Information for the Candidates

1. The provisionally listed candidates are required to attend the counseling between the following dates (on working days):

Reporting Date: 14-09-2026 to 25-09-26

Reporting Time: 10:00 am onwards

2. Admission is subject to satisfying the eligibility criteria for BMLS programmes as prescribed by Srimanta Sankardeva University of Health Sciences, Guwahati.

Eligibility Criteria: The minimum qualification for selection of the candidates is HSSLC (Science) (10+2) or equivalent with Physics, Chemistry and Biology, with English as one of the subjects, and securing at least 50% marks in aggregate in Physics, Chemistry and Biology for General & EWS Category and 40% marks for candidates belonging to OBC/MOBC (NCL)/SC/ST(P)/ST(H)/Divyang category, without grace marks.

3. Candidates must produce the following original documents along with a set of self-attested photocopies at the time of physical document verification:
 - a. Printed copy of the Application Form.
 - b. Birth Certificate/Certificate of HSLC or equivalent examination showing the date of birth.
 - c. Marksheet of 10+2 examination conducted by an authorised Board/Council.
 - d. If applicable, Passing Certificate of 10+2 examination conducted by an authorised Board/Council.
 - e. CEE Score Card conducted by **Srimanta Sankardeva University of Health Sciences, Guwahati.**
 - f. If applicable, valid SC/ST/EWS/latest OBC-Non-Creamy Layer (NCL)/PWD certificate issued by the competent authority for claiming admission under the reserved category. Candidates failing to produce the certificate will be treated as Unreserved Category candidates.
 - g. If applicable, latest EWS certificate issued by the competent authority. Candidates claiming admission against EWS seats should ensure that the certificate is valid on the date of admission; otherwise, the candidates will be considered under the General Category.
 - h. If applicable, Gap Certificate issued by the District Police Authority/Court affidavit, in case of a break in study for more than one year after passing the 10+2 examination.
 - i. Two copies of passport-size photographs.
 - j. PRC issued by the competent authority/Aadhaar Card.
4. **Fee Payable (Online) at the time of counselling/admission: Rs. 40,000/-**
5. Candidates reporting late (i.e., after announcement of their name) during the counselling/admission process may only be considered at the end of the counselling session.
6. Seats under reserved categories that remain unfilled will be converted into the Open Category in due course of time.
7. EWS reservation will be provided in accordance with Government norms.
